When a student is eligible for an Individual Reading Plan (IRP) after the BOY or MOY benchmark periods, enter the student into the program using the following steps. This is not where the content of the student's IRP is recorded. This is to record the creation and focus of an IRP for state reporting purposes. **IRP information should not be entered into the Infinite Campus RtA Program for 4th graders with a Reading Retained label. Only the Reading Retained Program Entry Status should be entered.**
