Adding Victim Resolution

Victim Resolutions have been added to the Core Attribute Dictionary. ([System Settings > Custom Data and Links > Core Attribute/Dictionary > Behavior > State Resolution Code \(61\)](#)). Any active code seen here should have a matching/corresponding Behavior Resolution Type available under [Behavior Office > Settings > Resolution Type Setup](#) in the **All Schools** context.

Districts must create the Victim Resolutions in Resolution Type Setup and map the appropriate state resolution code to the local resolution.


Adding Victim Resolutions

Context: *All Schools*

Navigation: *Menu > Behavior Office > Settings > Resolution Type Setup*

1. Select **New**
2. Enter the resolution **Code** based on the Victim Resolution chart listed below. (Ex. 200)
3. Enter the corresponding resolution **Name** based on the Victim Resolution chart listed below (Ex. Victim Offered Transfer)
4. Select **Alignment - Discipline**
5. Enter **Start Date - 07/01/2007**
6. Select the corresponding **State Resolution Code (Mapping)** based on the Victim Resolution chart listed below (Ex. Victim Offered Transfer)
7. Select **Save**
